**Nortel Networks B.V. (in administration) (the “Company”)  
Intention to adjourn creditors' and shareholders' meetings to 12 June 2017**

Following our letter and the notice of meeting sent to you on 5 April 2017, which informed you that meetings of the Company's creditors and shareholders will be held on 5 June 2017 to vote on the CVA proposal, it has been brought to our attention that 5 June 2017 is a national holiday in the Netherlands which may make it difficult for creditors and shareholders to attend those meetings.

The Administrators propose to adjourn the meetings on 5 June 2017 until 12 June 2017 to give parties as much opportunity as possible to attend those meetings should they wish to do so.

**Meetings of the Company's creditors and shareholders will be reconvened on 12 June 2017 at EY/HVG Law LLP, the address being Antonio Vivaldistraat 150 1083 HP, Amsterdam, The Netherlands. The creditors' meeting will recommence promptly at 10:30 a.m. Amsterdam time.**

You can attend the adjourned meeting on 12 June 2017 or vote in advance by completing a Voting Form. A copy of the Voting Form was enclosed together with the CVA Proposal sent to you on 5 April 2017 and is also available on the CVA Website <https://cva.emeanortel.com>.

Creditors whose Voting Forms have already been received by the Administrators will not need to resubmit their Voting Forms. **If you do not wish to attend the creditors' meeting but you wish to vote on the CVA proposal, you will now be able to submit a Voting Form until midday on 9 June 2017.**

We would remind all creditors that if you wish to attend the adjourned creditors' meeting at 10:30 a.m. Amsterdam time on 12 June 2017, you should also bring your completed Part A (*Details of CVA Claim*) to that meeting.
